As a result, <u>beginning May 1, 2020</u>, whenever Green Gardens has an available unit, three (3) referrals will be provided to Green Gardens from the “CES Match List,” which is drawn from the Coordinated Entry System (CES) and is based on the VI-SPDAT* score of the chronically homeless individual. The three (3) referrals will be the highest scoring chronically homeless individuals in CES who are served by the KernBHRS System of Care and/or Flood Bakersfield Ministries.</p> <p>These three (3) chronically homeless individuals will be screened by the Housing Authority of the County of Kern (HACK) and by either the BHRS Green Gardens team or Flood, using the process required by HACK as outlined here:</p> <ul style="list-style-type: none"> • One of the three will be selected to reside in the available Green Gardens unit. • The other two will remain on the CES Match List to be offered the first available housing opportunity that fits their needs, either at Green Gardens or elsewhere. • When another unit at Green Gardens becomes available, a new set of three (3) referrals will be provided to Green Gardens from the CES Match List. • To be placed into the 1st priority category in CES of chronically homeless individuals for a possible match to Green Gardens, the following documents must be in CES: <ul style="list-style-type: none"> ○ VI-SPDAT ○ Certification of Disability ○ Certification of chronic homelessness
